

ORDINANCE 2018-1

AN ORDINANCE TO MAKE TEMPORARY APPROPRIATIONS TO PROVIDE FOR THE OPERATION OF THE MUNICIPAL DEPARTMENTS OF THE VILLAGE OF MINGO JUNCTION, OHIO, FOR THE PERIOD FROM JANUARY 1, 2018 THROUGH MARCH 31, 2018 AND DECLARING AN EMERGENCY

WHEREAS, this Ordinance constitutes an emergency measure providing for the operation of the Village of Mingo Junction, Ohio, from January 1, 2018 through March 31, 2018, inclusive, and

WHEREAS, there are sufficient amounts of money available in the General Fund and other funds of the Village;

NOW THEREFORE, be it ordained by the Council of the Village of Mingo Junction, Jefferson County, Ohio, with two-thirds (2/3) of all members elected thereto concurring, that:

SECTION 1: In order to provide for the current expenses and other expenditures of the Village of Mingo Junction during the period from January 1, 2018 through March 31, 2018, the Council of the Village of Mingo Junction does hereby set aside and appropriate the amounts set forth in this Ordinance.

SECTION 2: That the following amounts be and hereby are appropriated from the Unappropriated General Fund:

a) Elected and Appointed Officials - Salaries and other expenses	\$ 22,000.00
b) Police Department - Salaries and other expenses	\$ 75,000.00
c) Fire Department - Salaries and other expenses	\$ 30,000.00
d) Service Department - Salaries and other expenses	\$ 30,000.00
e) Miscellaneous Areas - Salaries and other expenses	\$ 22,000.00

SECTION 3: That the following amounts be and hereby are appropriated from the various other unappropriated funds:

a) Water Revenue Fund - Salaries and other expenses	\$100,000.00
b) Sewer Revenue Fund - Salaries and other expenses.	\$ 65,000.00
c) Recreation Fund - Salaries and other expenses.	\$ 4,000.00
d) Garbage Fund - Salaries and other expenses	\$ 66,000.00
e) SM&R Fund - Salaries and other expenses	\$ 30,000.00
f) Employee Health Benefit Fund - Hospitalization.	\$ 65,000.00
g) Police Pension Fund - Salaries and other expenses.	\$ 14,000.00
h) Fire Pension Fund - Salaries and other expenses.	\$ 9,000.00
i) Parking Meter Fund - Other expenses	\$ 8,000.00
j) Drug Enforcement Fund - Salaries and expenses.	\$ 1,000.00
k) Senior Citizens Fund - Salaries and expenses	\$ 10,000.00
l) EMS Fund - Salaries and expenses	\$ 7,500.00
m) Cemetery Fund - Salaries and expenses	\$ 1,000.00
n) Capital Improvement Fund - Salaries and expense	\$ 5,000.00

- o) Street Improvement Fund - Salaries and expenses. \$ 5,000.00
- p) Employee Retirement Benefit Fund - Salaries and expenses. \$ 15,000.00
- q) Fire Equipment Fund - Salaries and expenses \$ 20,000.00

SECTION 4: The Village Clerk is hereby authorized to draw his warrants on the Village Treasurer for payments from any of the foregoing appropriations upon receiving proper certification and vouchers therefore, approved by the Officers authorized by law to approve the same or an Ordinance or Resolution of Council to make the expenditures, provided that no warrants shall be drawn or paid for salaries or wages except the persons employed by authority of and in accordance with law or Ordinance.

SECTION 5: This Ordinance is declared an emergency and shall be in force and effect immediately upon its passage and approval by the Mayor.
