

## RESOLUTION 2018-2

A RESOLUTION DECLARING THE NECESSITY OF ESTABLISHING A LEVY IN THE AMOUNT OF THREE MILLS ON EACH ONE DOLLAR OF VALUATION OF THE TAXABLE PROPERTY WITHIN THE VILLAGE OF MINGO JUNCTION, FOR THE PURPOSE OF PROVIDING FUNDS FOR THE PURCHASE OF AMBULANCES AND OTHER EMERGENCY MEDICAL SERVICE EQUIPMENT FOR THE VILLAGE OF MINGO JUNCTION, OHIO TO BE PUT TO A VOTE OF THE ELECTORS OF THE VILLAGE OF MINGO JUNCTION, OHIO

Whereas it is necessary and in the best interest of the citizens of the Village of Mingo Junction, Ohio to establish a three (3) mill levy for the Village of Mingo Junction, Ohio for the purpose of providing funds for the purchase of ambulances and other emergency medical service equipment for the Village of Mingo Junction, Ohio,

Now therefore be it resolved by the Council of the Village of Mingo Junction, Jefferson County, Ohio, that:

SECTION 1: Because the amount of taxes that may be raised by the levy of taxes at the maximum rate authorized by the Ohio Revised Code, Section 5705.19 on the taxable property in the Village of Mingo Junction, Ohio, will be insufficient to provide funds for for the purchase of ambulances and other emergency medical service equipment for the Village of Mingo Junction, Ohio, the levy of taxes of three (3) mills levied on the taxable property of the Village of Mingo Junction, Ohio for the period of four (4) years, at a rate in excess of such maximum rate authorized by the Ohio Revised Code, Section 5705.19 is necessary and must be established.

SECTION 2: That the form of the ballots to be cast at the general election to be held , Tuesday, November 5, 2013, as to the proposed tax levy shall read as follows:

" A replacement of the levy of taxes for the benefit of the Village of Mingo Junction, Ohio, by a tax levy for the purpose of providing funds for for the purchase of ambulances and other emergency medical service equipment for the Village of Mingo Junction, Ohio, at three (3) mills for each One Dollar (\$1.00) of valuation, which amounts to thirty cents (\$.30) for each One Hundred Dollars (\$100.00) of valuation for four (4) years, beginning with the tax duplicate year 2018, and to continue through tax duplicate years, 2018, 2019, 2020, and 2021. "

SECTION 3: That the Clerk be, and he is hereby directed to certify a copy of this resolution to the Board of Elections of Jefferson County, Ohio, at their office situated in the Courthouse Annex Building, North Third Street, Steubenville, Ohio in order that said Board of Elections may make the necessary arrangements for the submission of such question to the electors of said Village of Mingo Junction, Ohio, as provided by law.

SECTION 4: That the Board of Elections are directed to cause notice of such election to be published as required by law.

SECTION 5: That this Resolution shall take effect from and after the earliest date allowed by law.
